Participants may enter a maximum of three (3) events.

TO ENTER: Parents must register online at www.lagunabeachcity.net or submit a completed entry form together with the \$17 per child entry fee to the Community Services Department (380 Third St.) by Thursday, April 12th, at 4:00 P.M. (or \$22 at the event). Pre-registration is highly encouraged.

Barefoot running, spikes and cleats are NOT allowed. All equipment will be provided. NO starting blocks will be allowed. Medals will be presented to 1st – 3rd place finishers, and ribbons for 4th – 6th place finishers in each individual event.

Boys and girls who place 1st – 4th in any individual event qualify to join the Laguna Beach Track Team that will compete in the Orange County Municipal Athletic Association (OCMAA) novice track meet on Sunday, May 6th at a local High School. New this year - Registration for the OCMAA meet will be available onsite after the Laguna Beach Track Meet. If your child qualifies and is interested in participating in the May 20th track meet please bring a photocopy of your child's birth certificate or passport with a check for \$16 payable to the *City of Laguna Beach*.
